Two components (A+B) polyurethane system designed for the production of self-extinguishing rigid polyurethane foam. Density 35.2 kg/m3.

### 4. APPLICATION / LIMITATION:

4.1 - May be used on vessels granted with applicable refrigerating additional notations in accordance with Pt F Ch 7 of the Society's Rules. When used on vessels granted with applicable refrigerating additional notations the rigid polyurethane foam together with its surface lining shall satisfy low flame spread properties as per 2010 FTP Code, Part 5.

4.2 - Valid for use when applicable regulations do not require non-combustible material for bulkheading.

4.3 - The fitting aboard to be the same as used for the tests.

#### **5. PRODUCTION SURVEY REQUIREMENTS:**

5.1 - The **EKOPRODUR S0329** is to be supplied by **PCC PRODEX Sp. z o.o** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
